





QUALITY CONTROL

New 4-5 Elementary School, Site Improvements Package, and New High School

The monitoring of safety and quality of work is an important issue, which Robertson Construction Services and the Subcontractors take very seriously. Robertson continually monitors the Subcontractor's safety practices and quality of work via on-site inspections.

Quality Control

We are reviewing all of the "work in place" to verify it was installed as designed. Any discrepancies from the Contract Documents are listed in field reports and distributed to the proper Subcontractor for corrections. We also discuss the items in our weekly subcontractor meetings to ensure each concern has proper closure. The entire Design Team has taken a thorough and proactive approach to items. Robertson continues to monitor the reports from Geotechnical Consultants Inc. Corrections are being made in response to these reports.

Additionally, pre-installation meetings are being scheduled with the Architect and appropriate subcontractors to ensure the work is consistent with the contract specifications and on par with quality standards.

- High School Cast-In-Place Concrete (Footings) August 8th, 2019

- Elementary & High School Membrane and Sheet Metal Roofing October 8th at 3:00 pm
- Elementary & High School Mechanical Materials/Methods November 5th at 10:00 am
- Elementary & High School Fire Protection Materials/Methods November 19th at 10:00 am
- Elementary & High School Plumbing Materials/Methods November 19th at 9:00 am
- Site Work Clearing and Grubbing March 7th, 2019


