Executive Summary

Intermediate School – Punch work continues. 11 month walkthrough to be scheduled.

High School – Construction on-going. Courtyard work is underway. Finishes underway. Punch list is underway.

Off-Site Road Improvements – A kickoff meeting for the ODOT project was held on April 7th and the milestone date for the work outside the campus was confirmed. A meeting with ODOT was held on October 14, 2020 to discuss the ODOT project on SR 40. The US 40 plan set has been completed. The bid and project start date has been delayed. Once the project is awarded it will be 4 -8 weeks before contract is finalized and then preconstruction meeting is held. Work is expected to start in spring of 2021. First interim completion date is August 1, 2021 is for westbound land from Smoke road to the school right turn late and signalization. The signalization may be temporary depending upon the availability of the equipment. Second interim completion date October 2022 is for all pavement work both directions from Columbia Road to Kirkersville village limit to be complete. The remainder of the project is west of Columbia Road and is a resurfacing project and may run into third season. It would be expected there will be the need for the detour from spring 2021 until August 1, 2021. Phase 1 Culverts & West Bound Lanes. Phase 2 – East Bound Lanes. There will be intersection closures throughout construction for one to two weeks each.

Etna Elementary School – Demolition is complete and mechanical rough in has begun. The school district is exploring ways to address the roof repairs outside of the CMR contract at this time.

Watkins High School Renovation - Bid documents have been issued.

Kirkersville Elementary – Estimate reconciliation is still in process. Design Development has been pushed back to the end of May due to the delay in SD reconciliation.



Pataskala Elementary – The team is compiling additional information for the OFCC regarding the new building.


